## Membership Classifications

**Active Member** - Shall have reached the age of twenty-one and shall be entitled to all privileges of the Club, including holding office and voting at all called and general meetings of the Club. The immediate household of the active member shall be entitled to the privileges of the Club until they reach the age of twenty-one (age twenty-five if still enrolled as a student in college).

**Non-Resident** - Shall be persons having reached the age of twenty-one whose primary place of residence is located over a fifty mile radius from the Shreveport Yacht Club. They shall be entitled to all privileges of the Club as enjoyed by Active Members.

**Junior** - Shall be between the ages of twenty-one and thirty-two. Shall be entitled to enjoy all the privileges of the Active Member except that they shall not be eligible to vote or hold office. A Junior Member shall automatically become an Active Member on their thirty-third birthday, upon purchase of one share of stock and paying to the Club the difference between the amount of the initiation fee for a Junior Member and an Active Member with the exception that Junior Members with at least three years in good standing may attain Active status without paying additional initiation fees. The \$100.00 stock deposit will be credited toward their stock upon conversion to Active Membership status.

**Student Over 21** - Shall be between the age of twenty-one and twenty-five and be a full-time student in an accredited university. He/She shall automatically become a Junior member either upon graduation or on his/her twenty-sixth birthday.

**Military** - Shall be a member of the armed forces on active duty. Military members shall pay \$100.00 annually as an initiation fee; however, total payments shall not exceed the fee for an Active membership.



Membership acceptance requires signatures from two current voting members in good standing, signatures from two members of the Membership Committee, and signature from the Shreveport Yacht Club Commodore.
