



## Shreveport Yacht Club Membership Waiting List Information

Dear Applicant,

Thank you for your interest in becoming a member of the Shreveport Yacht Club. The club is currently at capacity and has a waiting list for new memberships. There is no way to predict the length of wait for a new membership since natural attrition rate is unknown. However, to help manage expectations we anticipate a potential 2-6 month wait for active membership.

In order to secure a spot on the membership waiting list the enclosed Waiting List Application, \$500 non-refundable deposit and two current member sponsor signatures must be submitted. These sponsoring members must be two separate memberships, a husband and wife on the same membership does not meet this requirement. Please be aware that for two individuals to apply for membership together they must be married or if unmarried share the same residence. If two individuals are unmarried and not sharing the same residence they must apply separately.

The club currently has an overall cap for full membership of 450. This membership cap has been put in place to help preserve the quality of the existing membership by not overwhelming the club in the summer months. Individuals that are on the membership "Waiting List" will have full access to the club from October 1st until April 30th and will pay dues for these months only. Individuals on the "Waiting List" will not be permitted to utilize the club from May 1st until October 1st. This policy will be strictly enforced and violators of this policy will forfeit their initiation deposit as well as their spot on the waiting list. At no time will individuals on the "Waiting List" be permitted to store boats or boat trailers at the club until they reach the status of a full-time member.

Upon membership approval by the membership committee and the current Commodore you will be notified of your position on the waiting list. You will also be notified monthly of any changes of your waiting list status. It is important for you to notify us of any changes in contact information while you are on our waiting list.

## Membership Classifications

**Active Member** - Shall have reached the age of twenty-one and shall be entitled to all privileges of the Club, including holding office and voting at all called and general meetings of the Club. The immediate household of the active member shall be entitled to the privileges of the Club until they reach the age of twenty-one.

**Non-Resident** - Shall be persons having reached the age of twenty-one whose primary place of residence is located over a fifty mile radius from the Shreveport Yacht Club. They shall be entitled to all privileges of the Club as enjoyed by Active Members.

**Junior** - Shall be between the ages of 21 and 25 inclusive. They shall be entitled to enjoy all the privileges of the Active Members, except that they shall not be eligible to vote or hold office. A Junior Member shall automatically become an Active Member upon purchase of one share of stock and paying to the Club the difference between the amount of the initiation fee for a Junior Member and an Active Member in effect at the time he/she reaches his/her 26th birthday, with the exception that Junior Members with at least three years standing may attain Active status without paying additional initiation fees. The change from Junior Membership to Active Membership shall become effective on his/her 26th birthday.

**Military** - Shall be persons who are on active duty or retired with any of the armed forces of the United States. Military members shall not have the right to vote or hold office, but may, upon acquisition of at least one whole share of Active Member stock and the appropriate initiation fees, convert such membership that of Active Member and enjoy all the privileges of that class. The immediate household of Military members shall be entitled to privileges of the Club until they reach the age of 21.

**Waiting List** - A \$500 non-refundable deposit and two current member sponsor signatures are required. The \$500 deposit will be applied to the initiation fee when a membership spot becomes available. SYC will contact applicants on the waiting list monthly to update their status on the list. Upon approval, applicants on the waiting list will have full access to the club from October 1st until March 30th.
