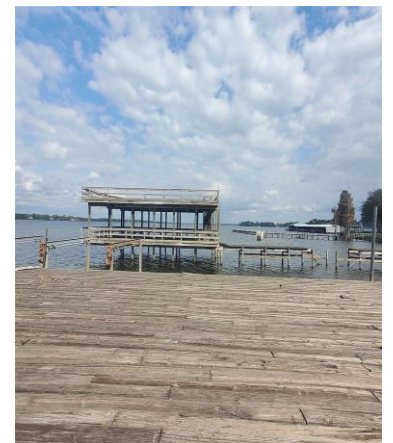

### Property Acquisition

The Board of Directors has acted on an opportunity to purchase the property bordering the Shreveport Yacht Club to the west, at 2901 Municipal Pier Rd., Shreveport. The negotiated purchase price is \$350,000, and the property consists of one acre of land, three buildings, 200+ feet of water frontage and some parking. The full purchase agreement is posted on the Club bulletin board.

This purchase must be approved by the membership at a special meeting scheduled for Thursday, January 16<sup>th</sup>, at 6:30pm in the Club Dining Room.
